The Indian science team wins the prestigious Indo-UK Biotechnology Challenge 2010. The event was held at Nottingham University on September 3, 2010 at the inaugural function of Academy of Pharmaceutical Sciences Conference, in the UK. The event was organized jointly by Nottingham Business School, IIM, Bangalore, and IIT, Kanpur.

The Indian team included Prof. Ashwani Nangia from Hyderabad Central University; Monika Verma, CEO of Avance Phytotherapies, Ahmedabad; and Dr Shivprakash Rathnam, CEO of Synchron Research Services, Ahmedabad. The team presented their proposal entitled 'chalk2salt', that basically involves converting the physico-chemically poor drugs into better
